ALSO, IN PROVIDING MY STATE APPOINTED ATTORNEY (WHOM HAVE SHOWED ME BY HIS UNPROFESSIONALISM THAT HE IS INCLINED TOWARD THE OPPOSITION) UNWARRANTED AND UNWANTED CONTINUANCES ON BEHALF OF THE DEFENSE OF THE DEFENDANT. I FIND ALSO THAT JUDGE HAS FAILED TO PROVIDE THE ACCUSED WITH LIBERTY, JUSTICE, FAIRNESS, AND IMPARTIALITY ON MY BEHALF. THESE UNETHICAL AND UNPROFESSIONAL JUDICIAL TACTICS HAVE DEPRIVED ME, THE DEFENDANT OF MY CONSTITUTIONAL RIGHT TO A FAIR TRIAL IN A TIMELY MANNER.
