**ORDER**

The complainant alleged that a superior court commissioner made improper threats, appeared to have his mind made up before hearing the evidence, and issued an incorrect ruling because of bias. The commission reviewed the complaint and found no evidence of ethical misconduct on the part of the commissioner. The minute entries available online indicate both parties were represented by counsel, and the commissioner received and reviewed a substantial amount of evidence before issuing a ruling. Whether the commissioner made correct rulings is a legal issue outside the jurisdiction of the commission. Accordingly, the complaint is dismissed pursuant to Rules 16(a) and 23.

Mr. Manes has complete control after Centuri made the statement "Mary doesn't have a clue" we knew Mr. Manes would get Ronie the whole trial leaned toward Mr. Manes taking away I can't understand why was put in a home of
