In accordance with Rule 31(c)(6) of the Arizona Rules of the Supreme Court, an annual membership fee shall be established by the Board of Governors of the State Bar of Arizona with the consent of this Court.

Upon the recommendation of the Board of Governors to increase the annual membership fees, the Court has considered the recommendation of the Board and desires to approve new fees.

Now, therefore, in accordance with the administrative authority vested in the Supreme Court by Rule 31(a), Rule 31(c)(6), and Rule 31(c)(7) of the Arizona Rules of the Supreme Court, the Court has considered the annual fee for membership in the State Bar of Arizona; and
