

**ARIZONA SUPREME COURT  
REGISTRATION FOR EXAMINATION**

**To Register:** Pre-registration is required. Complete this fillable registration form, print and submit with a \$50.00 fee made payable to the Arizona Supreme Court and send to Certification and Licensing Division, Arizona Supreme Court, 1501 West Washington, Suite 104, Phoenix, AZ 85007-3231. **Space will be reserved on a first come, first served basis.** Indicate your 1<sup>st</sup> and 2<sup>nd</sup> date of preference. Type or print the information clearly. Staff will confirm your registration by email. **Please arrive at least 15 minutes early to allow time to register for the exam. Registration will begin one half hour prior to the time indicated below.**

Re-registration fee of \$50.00 will apply for any applicant who registers for an examination date and fails to appear at the designated site on the scheduled date and time.

Reasonable accommodation will be provided to a qualified applicant with a disability in accordance with the Americans with Disabilities Act. If you have a disability and require an accommodation, contact the Certification and Licensing Division at (602) 452-3378 at least two weeks prior to the examination date as to the documentation to be submitted.

If you are sitting for the **Certified Reporter Examination and are NOT seeking reciprocal certification pursuant to ACJA § 7-206(E)(1)(b)**, please be prepared, as part of the application process, to present satisfactory evidence of completion of at least one of the following requirements:

1. Obtain one year of experience in making verbatim records of meetings, conferences, hearings or judicial or related proceedings by means of written symbols or abbreviations in shorthand, machine writing or voice writing and in transcribing these records.
2. Obtained a verified certificate of the satisfactory completion of a prescribed course of study from a court reporting school or a certificate from a school that evidences the equivalent proficiency and the ability to make a verbatim record of material that is dictated pursuant to rules adopted by the supreme court.
3. Obtained a national court reporters association's registered professional reporter or registered merit reporter certificate.
4. Obtained a valid certificate to practice court reporting that is issued by a state other than this state if the other state's requirements and certifying examination are substantially similar to or more stringent than those in this state.
5. Demonstrated reasonable proficiency in making verbatim records of trial or judicial or other related proceedings by passing an approved examination for certification pursuant to rules adopted by the supreme court.
